De Soto Heritage Festival Children's Parade Rules

1. Selections by Committee will be made for the following categories:

Floats:

- A. Best Use of Theme -\$1,000 Award Winner
- B. Most Imaginative - \$500 Award Winner
- C. Most Colorful - \$500 Award Winner
- D. Most Crowd Pleasing - \$500 Award Winner

All float decorating must be created and installed by children.

Adults may participate in preparing the float structure and assembly only.

Judges will deduct points for floats that appear to be decorated by adults.

The entries selected in these categories will be invited to participate in the April 28, 2012 De Soto Heritage Festival Grand Parade. Winners of these categories (Floats A-D) will receive the application including rules and **release waivers for Grand Parade** which **do include age restrictions.** Signs for floats winners participating will be provided.

Team Performances:

- A. Team Performance -\$500 Award Winner
- B. Best Cheerleading Team Performance - \$500 Award Winner

School Spirit Award: \$500 Award Winner

This will be awarded to the elementary school non-float entry judged to exhibit the most school spirit.

2. In keeping with prior parades and for the safety of all participants, **motorized vehicles will not be permitted.** It will be necessary to have children or adults pull the floats. **This includes commercial entries.**
3. As a safety precaution, **no** animals are permitted with any of the entries.
4. Please advise on entry form if your unit intends to perform so that we can place your unit in the lineup where it will not conflict with a band or another marching unit. For proper flow and the enjoyment of the crowd, participants are encouraged to perform during the parade with a forward movement. **Do not stop during the route.** Your group will have an opportunity for a stopped performance at the judge's stand. The judge's stand is located at Sutton Park on the west side of the parade route. We request that this performance be limited to no longer than 45 seconds.

In no case shall participants be allowed to have multiple performances by small individual groups within their overall school participants. Multiple applications will not be accepted by an individual school. If you intend to have multiple performances they must be completed in the 45 second time allotment.

5. Music that will be supplied for performances must not be offensive.
6. All participants are asked to make every effort to keep their group moving to preserve the continuity of the parade.
7. All floats must adhere to the theme of the parade.
8. With the exception of chaperons for small children, the maximum age for participation in the parade is 18 years.

Application deadline is March 23, 2012.

9. The 2012 Hernando de Soto Historical Society's De Soto Heritage Festival Children's Parade requires a certificate of insurance in the amount of \$1,000,000 naming Hernando de Soto Historical Society, Inc., its Board of Directors, its staff, their members, agents and sponsors as additional insured.
10. Please contact your insurance agent. Your insurance certificate must be received in our office no later than March 23, 2012.
11. Cancellation Clause: This policy of liability insurance shall not be cancelled or suspended or terminated, nor shall the limits of liability be reduced until after thirty days notice thereof is given by certified mail to Hernando de Soto Historical Society, Inc., 910 Third Avenue West, Bradenton, Florida 34205.
12. Judging for the "Best Use of Theme Award", as well as other categories, is **subjective and will be weighted to the entries that the decoration have been handmade and applied by children.** Traditional float decorations such as premanufactured fringe, garland, petal paper etc. will be allowed. For safety, parents are encouraged to participate in the construction of the theme base, backdrops and background items, as well as final assembly.

The safety of your children is our number one concern and the decision of the Parade Committee is final.
